# RESOLUTION OF THE BOARD OF DIRECTORS, MADERA IRRIGATION DISTRICT APPROVING THE 2024 REVISED CROP WATER DISTRIBUTION POLICY

**RESOLVED** by the Board of Directors of the Madera Irrigation District ("District"), at a special meeting duly called and held on May 1, 2024 at the business office of the District, 12152 Road 28 1/4, Madera, California 93637 as follows:

**WHEREAS**, the District has determined that the District may have sufficient water supplies to deliver surface water during the 2024 water year; and

**WHEREAS**, to accommodate the delivery of water supplies this year, and to promote the orderly delivery of water, District staff has recommended a proposed revised 2024 Revised Crop Water Distribution Policy, a copy of which is attached hereto as Exhibit "A"; and

**WHEREAS**, the Board of Directors of the Madera Irrigation District reviewed and considered the proposed Revised Crop Water Distribution Policy at its board meeting on May 1, 2024 and has determined that adoption of the 2024 Revised Crop Water Distribution Policy is in the best interest of the District.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Directors of the Madera Irrigation District, that the facts contained in the recitals above are true and correct and that the Board of Directors of Madera Irrigation District approves the Revised 2024 Crop Water Distribution Policy.

Flat Rate Water Users payments will be due in accordance with Section 3 of the District's Rules and Regulations.

### **PAYMENT FOR CROP WATER:**

Payment is due upon receipt of the monthly invoice. Payments must be received in the office by 4:00 p.m. on the last business day of the month and will become delinquent on the following day. Payment due dates are May 31, June 28, July 31, August 30, and September 30, 2024. Water service will be terminated if payment is not received by 4:00 p.m. on the due date. A 2% penalty will be charged on the unpaid balance without exception. Postmarks are not acceptable as evidence of timely payment. Returned checks will result in a \$30 returned check fee. Thereafter, only cash, cashier's check, certified check, or money order will be accepted.
