# Survey

- What is a survey?
  - A place to share an opinion
  - Non-binding and voluntary
- What are the benefits of a survey?
  - Draw from a large pool
  - Low amount of effort for respondent
- What are the drawbacks of a survey?
  - Tends to attract those with strong feelings
  - Survey exhaustion is real
- What is the information used for?
  - Gathering data on opinions



## We Have Learned from Surveys

- Programs and Communication
  - More than 80% familiar with the GSP
  - Email and e-newsletter preferred communication method
  - Recharge, allocation, land repurposing preferred solutions to overdraft
- Multi-benefit Land Repurposing
  - Most desired project type: recharge, solar, less water intensive crop
  - Most desired multi-benefit: water quality, air quality
- Programs, Measurement and Communication
  - Overwhelming support for multiple measurement methods
  - Majority had not encountered issues with their measurement
  - Preferred communication was with their Water Resources
    Specialist



# **Survey of GSA Rate Alternatives**

- County conducted informal survey to gauge grower interest in alternative rates
- Aug 10 Surveys were mailed to 230 growers
- Aug 20 and 27 All growers were emailed to remind them to submit survey; follow up phone calls made
- Respondents were asked to return surveys by August 31

#### Dear Valued Farmers

The Board of Supervisors (acting as the Board of Directors for the County GSA) is exploring ways to reduce your groundwater rates in the County GSA, Madera Subbasin, including pursuing grants, looking for cost-saving measures, and evaluating partnerships. If a temporary injunction on groundwater rates is lifted, the Board may assess a lower alternative rate for projects in addition to the GSA Admin Fee. Along with a potential reduction in rates comes a smaller scale of projects and a corresponding reduction in expected 2040 allocations. Below is a table of potential rates. All alternatives are subject to additional review. Please indicate your preference and then tear off and mail the postcard back or take a picture and email it to the address provided. Results of this survey will be presented to the Board of Supervisors acting as the Board of Directors in September 2024.


# **Survey Results**

	Alternative #1	Alternative #2	Alternative #3	Adopted Rate
Approximate Rate	\$65	\$95	\$170	\$246
Responses	17	4	4	8
Responses (%)	52%	12%	12%	24%



# **Survey Results + Written Responses**

Responses (%)	64%	9%	9%	18%



### **Conclusions**

- The survey is not intended to be a statistical analysis, but instead to gather information and gauge grower interest in alternative rates
- Low response rate among Farm Units in the Madera GSA
  - One in five Farm Units responded to the County GSA Survey
  - Four in five Farm Units did not respond to the County GSA Survey
- Preliminary analysis suggests respondents are not a representative sample and are skewed toward larger farms and operations
- We can come back with further recommendations if additional analysis is requested
