1. The meeting was called to order at 1:31 pm, by Bobby Macaulay, chairperson.

2. Review & Approval - Agenda & Minutes

- A motion to approve the April minutes and June agenda was made by Phil J; Carl J second; all voted; Motion passed unanimously.

3. Public Comment

- Clyde W asked if the lakes within Indian Lakes is within jurisdiction of the group, it is non potable water but is a resource for wildlife within the area. Bobby M mentioned that he does not believe that the Madera RWMG is particularly interested in the management of lakes and ponds within the County. The lakes in Madera County are under the control and maintenance of the County. Theoretically, ponds and lakes are to be managed by the communities. Bobby and Celeste will discuss this topic more offline.
 - Carl J added that there is probably a State permit and a State water right that's involved with those lakes.
- Items of interest were mentioned by Jacob R (for more information, reach out to Jacob):
 - A [first-of-its-kind study on the Merced River Watershed](#) has examined the effectiveness of Flood-MAR to reduce flood risk, improve water supply, and enhance ecosystems.

- New fact sheets describing general information about California water rights and reporting requirements have been released by the State Water Resources Control Board.
- The USA NRCS Watershed and Flood Prevention Operations Program is currently accepting applications. This grant has a rolling deadline.
- DWR has released the [Spring 2024 Semi-Annual Groundwater Conditions Report](#), which provides a look back at groundwater conditions during California's historic 2023 Water Year.
- The next Irrigated Lands Regulatory Program (ILRP) Stakeholder Meeting will be held online via Zoom on Wednesday, June 26th. The meeting is open to the public and all interested stakeholders.
- [The California Fire Foundation \(CFF\): Statewide Grant Opportunity](#) is accepting applications through June 30th. This program supports projects that actively address wildfire preparedness and/or prevention needs, including vegetation management, education, planning, community outreach, and specialized equipment.
- [The US Bureau of Reclamation Tribal Domestic Water Supplies Program](#) is accepting applications through August 4th. This program supports water projects to provide domestic water supplies to existing tribal communities or households that do not have reliable access to domestic water supplies.

4. Discussion & Action - Financial Report/Warrant Approvals

- June 2024 Financial Report
 - Jacob R reported that there has been no movement with financials for the month. We started and ended the month with \$24,560.50.
 - A motion to approve the June financial report was made by Gretchen H; Phil J second; all voted; Motion passed unanimously.

5. Review & Approval – Madera RWMG Accounting Functions

- Jacob R mentioned that he sent out a draft contract for review to all of the group members, and the contract is for Anthony Forestiere. He handles the accounting functions for SEMCU. The contract will start on July 1st this year, expire at the end of June next year, and be renewed yearly.
 - Carl J asked if Anthony is bonded, and Jacob mentioned that he does not know. Al S added that he does not know either.
 - Keith H mentioned that Anthony is an employee for the City of Madera. There needs to be a couple of things that Anthony works through between himself and the finance department. Keith thinks that this position or contract is doable between this work and his job with the City; however, he does need to address one thing between himself and the finance department manager. If this does not work out, the City does have a finance manager that has been there for many months and he has offered that the City of Madera can take on the duties for accounting if so desired

by the group. Jacob asked if there was a fee that the City would want to charge. Madera ID was charging \$450/year. Keith hasn't followed through with the finance department manager on compensation, but Keith thinks it would be nominal. Bobby M thinks this would be a good course of action to take for the accounting functions.

- Bobby mentioned to get a draft contract going with the City and bring it to the group next month for approval. Bobby asked Keith if it would be better to just move forward with the City handling the accounting functions, and Keith mentioned it depends on the preference of the group. Anthony is very good at what he does. Bobby added his preference would be the lowest cost option and the larger economies of scale. Jeannie H added that for the accounting functions, there is the accounting part of it, the auditing part of it, and writing the checks for the group. Anthony as an individual couldn't hold a checking account for the group. As Madera ID was doing, they were paying our bills, keeping track of everything, and they held the contract for the group coordinator. The group cannot hold a contract because we are a nonentity. The contract for the coordinator has to be held with the group or agency that is writing the checks since they have the W9 for the coordinator, and that would be the City. Jeannie does not think Anthony could do this as an individual.
- A motion to give authority to Jacob R to move forward with getting a contract together for the City of Madera to handle the accounting functions was made by Gretchen H; Phil J second; all voted; Motion passed unanimously.

6. Discussion – Proposition 1 Disadvantaged Community Involvement Funding

- San Joaquin Valley
 - Chowchilla Nitrate Control Program / Chowchilla Management Zone – Projects 12 and 13
 - Becky H reported that they are continuing their outreach efforts and are still getting some applications trickling in. They had an outreach booth at the Chowchilla Fair in May and had some good conversations with attendees. Becky and a few others at today's meeting attended the SHE Water Tour and they continue to partner with SHE on many topics related to water. The Prop 1 grant has expired. CMZ is also working with the Chowchilla WD who has recommended some individuals who are applying for assistance to drill new domestic wells. As the wells are being drilled, these individuals are contacting CMZ to have the water tested for Nitrates. They are starting to reach out to the public water systems in the Chowchilla area to see if they are interested in joining CMZ. There are about 12 of those groups.
 - Jacob R added that CMZ and himself are working with DWR on getting the grant closed out. One of the hurdles they ran into is GeoTracker and the test result data being made public. Jacob does have a backup deliverable for this since DWR does want it to be GPS or GIS tracked with the addresses that were on the test results obtained and paid for using this funding. They are also

wanting a database which Jacob put together. Jacob shared the database with meeting participants. Please see the end of these minutes for the database. The font may be small, so please contact Jacob for the original spreadsheet which will allow zooming to make the font larger and legible for some.

7. Discussion – Proposition 1 IRWM Implementation Funding

- San Joaquin Valley Counties
 - Parkwood
 - Fahed M reported that Public Work’s field staff have finished installing the final 2 meters for this project. They are working on sending out the deliverables to DWR, getting everything reimbursed, and ordering any necessary equipment needed to read the system and meters. From a construction standpoint, everything is completed.
 - City of Madera
 - Keith H reported that there are a number of meters for this project that are still on order. The project is moving along. The contractor for the City that has been working on this project has been difficult to get ahold of so there is a lack of update on this project for now.
 - City of Chowchilla
 - Jason R reported that the contractor is moving forward and is on schedule. They’ve recently completed most of the retention basins and now they’re working on trenching for the pipe through the park. After the trenching, they will start on Sonoma Ave. Project is going along smoothly and should be completed by December.

8. Discussion – SGMA Implementation Grant

- Gretchen H reported for the various projects going on under this grant:
 - Grant administration continues. The formal amendment that was requested for Project 4 (Root Creek WD) was approved and executed. Pay Request and Progress Report 7 was approved by DWR on 5/28/24. Pay Request and Project Report 8 development will begin in July.
 - Project 2 – The groundwater model update is ongoing.
 - Project 3 – The Incidental Take Permit (ITP) was received, and they are waiting on the Division of Safety of Sams (DSOD) permit. They are continuing to work on obtaining easements prior to moving forward with finalizing plans/specifications for construction bidding. A grant amendment will be necessary due to the delay in obtaining permits and final easement. An amendment request was made on 5/23/24.
 - Project 4 – This project is complete and in operation.
 - Project 5 – No new information to share.

9. Discussion – Drought Working Group

- Jenny N reported that they had a meeting this past Friday. Professor Safeeq Khan from UC Merced presented on climate resiliency: water and drought. 24 people attended the meeting on Zoom. Attendees included representatives from the State, RCDs, and nonprofits.

- Jenny added that for the Drought Plan, they are working on making revisions. The plan has not been adopted yet.
- Also, for the funding received for SB 552, they are working on getting a contract with the mediator to develop the rules for the Madera Subbasin. This has to do with the domestic well mitigation in the Madera Ranchos area.

10. Discussion – Sierra Highlands Water Treatment Plant Project

- Fahed M reported that the funding received for this project is not sufficient to complete all of the work. They are exploring options of transferring the funds over to the Hidden Lakes project that the Public Works department is currently working on. Fahed reached out to two different contacts within DWR since the Sierra Highlands Project funding was received from IRWM and the Hidden Lakes Project funding was received from the Small Community Drought Relief Program. In order to move the funds from the Sierra Highlands project, the funds will need to be assigned to a specific task for the Hidden Lakes project. In order to do this, written approval needs to be obtained from the Madera RWMG and the Hidden Lakes project needs to be on the group's IRWMP Project List. The Hidden Lakes project is currently ongoing, and is scheduled to be completed in November. There are 2 other items needing to be done to transfer the funding, which Fahed is able to complete. Jacob R will send the link for the project proposal form to Fahed so the group can formally approve the Hidden Lakes project to be added to the IRWMP Project List to make it eligible to receive IRWM funding.
 - Stephanie A asked what the Hidden Lakes project is for, and Fahed mentioned it is to install two new water tanks. Bobby M added that Hidden Lakes is near Millerton Lake, and services roughly 40-lots. They have been having water issues since 2007. This project won't solve all of the water issues they have out there, but will significantly improve their water system. Hidden Lakes currently has 3 ongoing projects. The water tanks being one project. Another project is for a surface water treatment plant which Public Works is trying to get reimbursed through DFA next month. The 3rd project, which they are waiting on the Bureau of Reclamation to approve move forward on, is for the pipeline of the Hidden Lakes water tank project.

11. New/Suggested Members for the Madera RWMG

- Stephanie A mentioned to reach out to Aliso WD / GSA again. Bobby M asked Jacob R to CC him on the email this time around.
- Bobby M mentioned the Yosemite Lakes Utility Group joining, and Jacob R mentioned that they are still interested but have been going through some restructuring with their Board. Jacob made a presentation at one of their Board meetings last year back in June about the Madera RWMG and what we do. The Board did approve to join the Madera RWMG last year, but now they are going through restructuring so they are just working through those details before submitting a membership application.

12. Future Agenda Items

- Jacob R will add the Hidden Lakes project proposal to the agenda for July.

13. Next Meeting

- Next meeting is scheduled for Monday, July 22, 2024, on Zoom

14. The meeting was adjourned at 2:10 pm.

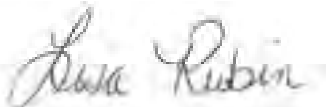

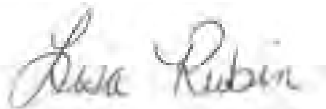

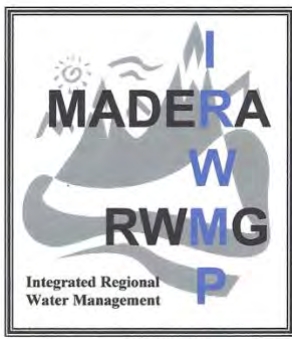

PROPOSITION 1, SAN JOAQUIN RIVER FUNDING AREA
DAC INVOLVEMENT GRANT
PROJECT 13

After reviewing the test results for 44 domestic well water quality samples performed under this project, Nitrate is the major concern for drinking water within the Madera IRWM boundaries. There are other concerns as well based off the test results: Coliform, E.Coli, 123-TCP, Arsenic, Lead, and Uranium. Here is a review of the test results:

- For Nitrate, four tests are above the safe threshold of 10 mg/L (US EPA) for drinking water, four tests are near the maximum safe threshold level, and five tests show a reason for concern.
- For Coliform, seven tests are above the safe threshold of 0 per 100 mL (US EPA) for drinking water.
- For E.Coli, one test is near the maximum safe threshold of 10 count per 100 mL (US EPA) for drinking water.
- For 123-TCP, one test is above the safe threshold of .05 ug/L (US EPA) for drinking water.
- For Arsenic, two tests show a reason for concern when compared to the safe threshold of 10 ug/L (US EPA) for drinking water.
- For Lead, one test shows a reason for concern when compared to the safe threshold of 15 ug/L (US EPA) for drinking water.
- For Uranium, one test is above the safe threshold of 15 pCi/L (US EPA) for drinking water, and one test showing a reason for concern.

Based off the review above, Point of Use (POU) systems for treatment may be the most cost effective and quickest way to address the concerns shown in the test results as a temporary solution until a permanent solution is found. Currently the State offers programs to fund water tanks at homes for water deliveries and also bottled water programs as a temporary solution, but those programs have recently experienced delays in the application processes and not all homes may qualify. Outreach through public workshops, Public Service Announcements (PSAs), community events (open house for schools, County fairs, public events like car shows, etc.) are the most effective way to reach a broad audience in order to spread awareness about the type of contaminants commonly found in drinking water supplied by privately owned domestic wells that are untreated.

During the project, many forms of outreach activities were performed. While some proved to be more effective than others, people were still contacted and notified about the project and the benefits that households can gain from participation. Successful outreach activities performed under this grant included flyers sent to households via USPS, word of mouth, partnerships with local organizations, nonprofits, and community groups, booths at outreach events (County fairs, flea markets, community events, etc.), and local free workshops.

After completion of this project, it is still evident that more domestic well testing is needed throughout the Madera IRWM boundary to get a firmer grasp on the contaminants that households deal with in their drinking water when it comes to domestic wells, and also to educate households on the possible contaminants they are being exposed to and the potential health risks themselves and family members may experience (whether immediate or later on in life). Many projects are currently addressing these issues throughout the state, but a more tailored project for the Madera IRWM region would be greatly beneficial and allow a more “welcomed” approach for outreach that proved to be effective during this project.

Executive Summary

On January 31, 2019, the Department of Water Resources (DWR) initially awarded a grant to the Contra Costa Water District (CCWD) under Grant Agreement #4600012737 to fund DAC involvement activities in the San Joaquin River Funding Area (SJRFA).

Madera County received funding as a Local Project Sponsor (LPS) under this Grant Agreement under Project #9 (Madera Regional Planning Project). A total of \$148,000 was awarded under Project #9.

Madera Irrigation District received funding as an LPS under this Grant Agreement under Project #12 (SJRFA DAC Technical Assistance) and Project #13 (SJRFA DAC Capacity Building). Projects #12 and #13 were included under Grant Agreement #4600012737 to provide technical assistance, project planning and development, environmental documentation, and design support services for SJRFA DAC projects in response to the Needs Assessment performed under Project #2. As such, the original Grant Agreement included placeholder tasks for the scope of services intended to be performed under Projects #12 and #13. Stakeholder Summary

DACs, EDAs, and underrepresented communities in Madera County have very unique needs when it comes to water management, and also very similar needs with communities across California. Madera County, along with all of the Central Valley Communities, have a big impact from agriculture when it comes to groundwater. Many counties have small communities that are surrounded by agriculture where a lot of the economy is derived from. Many households in these small communities depend on domestic wells to supply water. These domestic wells have seen dramatic impacts from groundwater levels dropping, including decrease in water flow/pressure which sometimes lead to wells drying up altogether, and an increase in contaminant levels.

Throughout this project, it became evident that homeowners or renters were unaware of the impact that decreasing water levels have on their water quality, but many understood the impact it has on their water availability. Throughout the project during outreach events, many homeowners and renters had questions in regards to water availability and what could be done versus what is currently being done to protect domestic wells from drying up during drought events. Many resources were distributed to homeowners currently being affected by or with a possibility of being affected by drought events during the duration of this project, along with testing of the domestic wells for contaminants, primarily Nitrates.

Point of use (POU) systems were very popular among the questions asked by homeowners and renters when it came to the quality of their water. Others were satisfied with programs supplying bottled water and/or water delivery to water tanks if their water was deemed unsafe to drink based off testing performed. These programs are temporary, but homeowners and renters were glad to learn about programs to support them regardless of the fix being temporary or permanent. After reviewing test results with homeowners and renters impacted by this project, they became aware of the potential risks, if not already, they could face in the near future as groundwater becomes more of a scarce resource in California.

Some water management needs that became evident during this project include: managing groundwater use for agriculture and increasing efficiency, managing groundwater use for landscape and urban water use efficiency, planning the distribution of water resources strategically throughout the year, surface water management for agriculture and increase in surface water storage, groundwater recharge (Flood-MAR) and recharge area protection, drinking water treatment and distribution, drought preparedness, conjunctive management, land use planning and management, matching water quality to water use, outreach and education, and watershed management.

The DACs, EDAs, and underrepresented communities involved in this project were derived from the DWR DAC mapping tool available online and pictured below. The stars on the map represent communities involved in domestic well testing, but the entirety of Madera County was contacted throughout various forms of outreach, including: door-to-door canvassing, mailer flyers and flyer handouts, email blasts through local school districts, workshops, outreach events (County Fairs, flea markets, etc.) cold calls, Facebook advertising, and word of mouth.

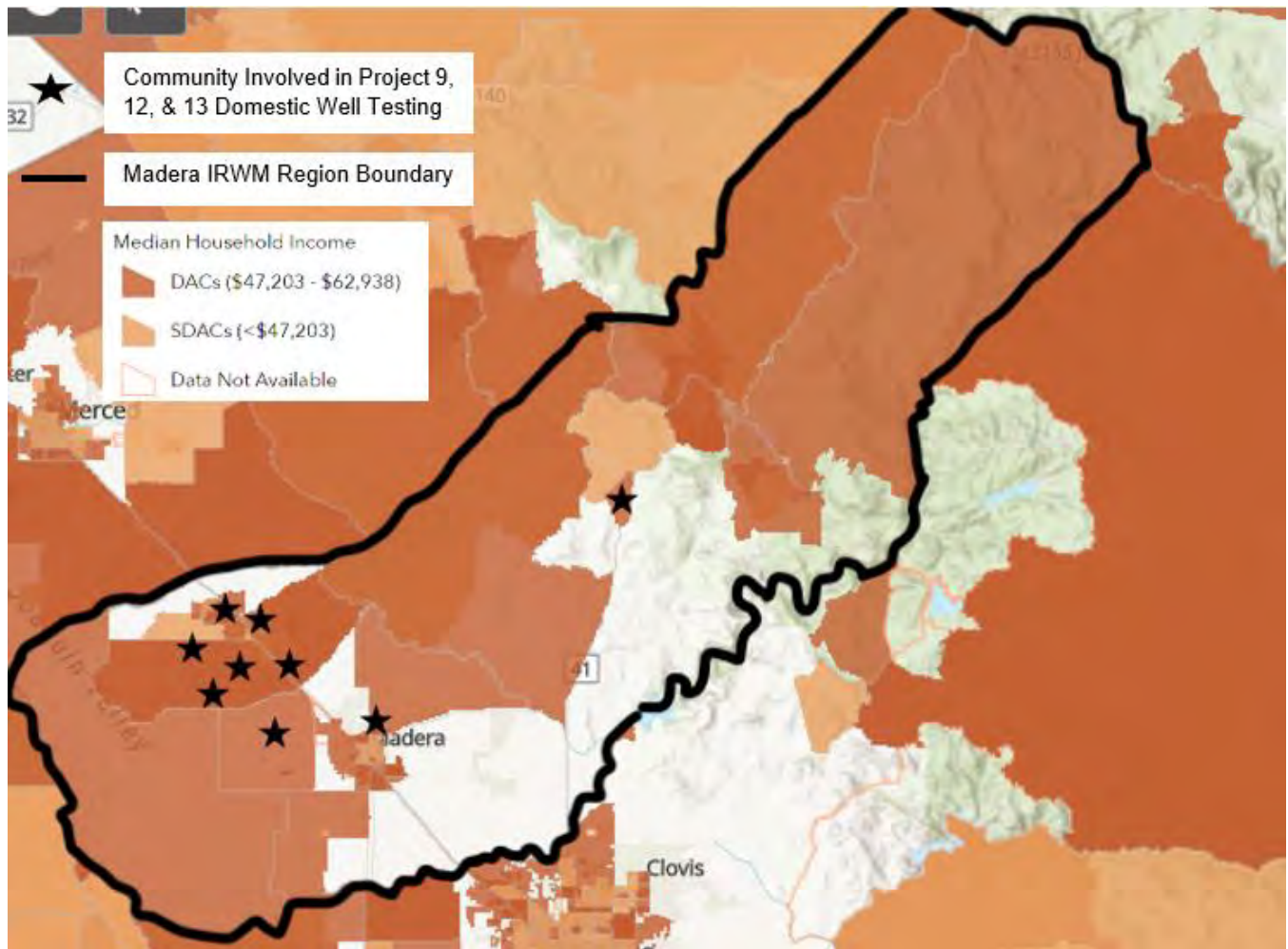


Figure 1: DACs, EDAs, and Underrepresented Communities Involved in Projects 9, 12, & 13

Figure 1 identifies different DACs, EDAs, and underrepresented communities involved in the project.

Involvement Activity Summary

Many forms of involvement activities were performed for this project, with some being more successful than others. Door-to-door canvassing was an activity performed as outreach for this project which was unsuccessful. Many of the DACs were more inclined to reject this project when door-to-door canvassing was used. Cold calling was also a technique used at the beginning of the project which resulted in 0 applications received. When the door-to-door canvassing and cold calling was unsuccessful, Facebook

advertising was used which was being seen by a lot of individuals on social media, but still not a lot of homeowners and renters were scheduling testing to be done for their domestic wells. Flyer handouts were done in partnerships with local school districts to help advertise this project which had some success and increased the number of applications received for the domestic well testing to be performed. Along with the flyer handouts, email blasts through school districts were also done. Advertising at local workshops and outreach events (e.g., County Fairs, flea markets, etc.) also proved to be successful, as the increase in applications was high after these events.

The most successful outreach activity performed was sending out mailer flyers targeting DAC zip codes. This resulted in over half of the applications received for domestic well testing. Word of mouth built on this success, as once homeowners and renters had their wells tested, they were telling friends, neighbors, and family relatives about the program. A number of homeowners and renters even had their well tested again to see if the contaminant levels dropped after the wet 2022 – 2023 winter season that California had.

Towards the end of the project, partnerships with trusted local organizations, nonprofits, and community groups were starting to form. No individual projects were developed from this project, but these partnerships will be leveraged for future projects to increase the outreach and benefit for DACs in Madera County.

Findings

Many DAC homeowners and renters are unaware of IRWM in their region. Many DAC residents have been excluded in policy setting or decision-making processes, leading to systemic inequities related to environmental hazards, socio-economic burdens, or both. These inequities can create mistrust among marginalized communities. Partnering with trusted local organizations and community groups can help foster trust and increase DAC involvement with the Madera Regional Water Management Group (RWMG) and projects they receive funding for.

For future activities, it is recommended that DAC residents have a forum where they can voice their concerns and provide input on where assistance can be most beneficial.

Looking into the Future

For the Madera RWMG, next steps include increasing DAC participation in the RWMG monthly meetings. Several DACs already participate in the monthly meetings, but increasing that participation will help increase overall awareness of the group's function, how the community can benefit, and will also benefit the success of the Madera RWMG by providing assistance to those who need it most.
