# MINUTES OF THE SAN JOAQUIN RIVER EXCHANGE CONTRACTORS WATER AUTHORITY FINANCE COMMITTEE MEETING HELD FRIDAY, JULY 26, 2024

The Finance Committee of the *San Joaquin River Exchange Contractors Water Authority* (*SJRECWA*) met in Regular Session on Friday, July 26, 2024, in the Board Room of the *San Joaquin River Exchange Contractors Water Authority*, 541 "H" Street, City of Los Banos, County of Merced, State of California.

#### **CALL TO ORDER**

Chris White called the meeting to order at 8:30 a.m. and reported there were no changes to the agenda.

#### **PUBLIC PARTICIPATION**

#### APPROVAL OF MINUTES OF THE JUNE 28, 2024 FINANCE COMMITTEE MEETING

The unapproved minutes of the June 28, 2024 Finance Committee meeting were presented. A motion was made by Jeff Bryant and seconded by Chris Cardella to approve the minutes as presented. The motion was unanimously carried.

#### <u>JULY 2024 GENERAL BUDGET COMPARISON</u>

The July 2024 General Budget Comparison was presented with revenue to date at 73% of budget after receiving 3<sup>rd</sup> quarter dues, and expenses currently at 53% of budget.

#### JULY 2024 WATER TRANSFER BUDGET COMPARISON

The Water Transfer Budget Comparison for July 2024 was reviewed reporting revenue at 75% of budget and expenses at 28% of budget through the end of July.

#### JULY 2024 WATER RESOURCES PLAN (GENERAL) BUDGET COMPARISON

The General Budget Comparison for the Water Resources Plan was next outlined.

### JULY 2024 WATER RESOURCES PLAN (PARTICIPATION AGREEMENT) BUDGET COMPARISON

The revenue and expenses for the Water Resources Plan Budget under the Participation Agreement were presented reflecting 75% of budget for revenue versus 23% of budget for expenses as of July 31<sup>st</sup>.

## JULY 2024 SAN JOAQUIN VALLEY DRAINAGE AUTHORITY BUDGET COMPARISON

No changes were made to the San Joaquin Valley Drainage Authority Budget Comparison from the previous report.

#### JULY 2024 CASH ACTIVITY REPORT AND EXPENDITURE LIST

Upon review of the July Expenditure List and Cash Activity Report, a motion was made by Chris Cardella and seconded by John Wiersma to recommend approval of the July 2024 financial report as presented. The motion was unanimously carried.
