- Farm Bill remains in limbo
- o 2008 Farm Bill extended through September 2024
- EQIP program has had an abundance of applications this year, the Madera field office has contracted three times the amount they typically do per year.
- Title 2 is extended through 2031 through IRA
- Madera Field office had the most applications preapproved through the State
- o 27 obligations, all forestry and 2 rangeland projects
- Recharge will be coming back next year, right after October 1<sup>st</sup> reach out to NRCS if interested in moving forward with a project

- Dave and Blair will be assisting the Madera Field office with engineering while finding a replacement for Prospero
- October 9th a new planner Niel will be starting with the Madera Field office

#### VII. RCD Report: Board Action Items and Discussion Topics

- A. CDFA Mobile Irrigation Lab (I) Kevin Reyes
  - O1 irrigation evaluation is scheduled, Kevin is finishing up final reports. So far Madera has 26 evaluations total. 12-14 reports have been completed and sent back to growers.
- B. CDFA Agricultural Planning Grant (I) Kevin Reyes
  - OKevin has been working with another biologist, Point Blue, on setting up site visits with growers. He's been training on how to complete site visits independently. He will contact Rex Dufour for additional assistance. We currently we have 3 evaluations in progress, 1 is complete, 6 signups.
  - Kevin has a site visit scheduled with Cate Mong/Point Blue at a cattle ranch on 9/12
  - Looking for rangeland site visits
- C. NRCS Equity Project (I) Amy Siliznoff
  - OAmy met with Sara Tiffany, CAFFs Director of Ecological Farming and her colleague Hanna on May 22<sup>nd</sup>. We're planning on a collaborative cover crop/water and irrigation field day event. Amy requested an additional 6month extension to this grant, for an end date of March 2025.
- D. DOC MLRP (I) Amy Siliznoff
  - RCD team has been attending the statewide DOC MLRP meetings, monthly
    partner DOC meetings, and bi-monthly partner meetings for project planning.
    The team is working on reviewing Deborah's contract as well as the draft

MALRP for structuring the incentive payment for growers through this program. The La Vina incentive payment has been proposed to Deborah and she's signed the Landowner Access Agreement to move forward with the project. The next step will be for her to sign the MLRP contract. The RCD will be assisting with the implementation of the project.

#### E. WCB Pollinator Block Grant (I) – Kevin Reyes

- Kevin is working on the Hillside Elementary School project with Jon Cottington from Coarsegold RCD, we are partnered on this project
- Arranging another school site visit to get familiar with where the school would like to plant. Great Valley seed and Xerces gardening list. Mariposa native nursery.
- Amy to reach out to Tesoro Viejo to see if they'd want to incorporate a pollinator garden in the urban area of their property
- OGoing over pollinator curriculum for the kids at the elementary school. Planting is during the fall. The school has big garden beds located at the front of the school. This is where the project will be implemented.

#### F. SBIR II – Amy Siliznoff

- Software IMO will Collin, how to calibrate model with Collin, use in data collection process
- Kevin finished nuclear gauge safety and HAZMAT certification to transfer neutron probe
- Kevin will be meeting with Collin September 12<sup>th</sup> to discuss more about the next steps
- OHe purchased new telemetry equipment.
- Amy to reach out to Collin if extension will be made to the contract, supposed to end September 30<sup>th</sup>

The workshop will focus on the why, how, what of organic transition and have a "resource fair" where TA providers local to the San Joaquin Valley can chat with growers about the resources that they provide.
- OAmy will present on our current La Vina pollinator project/hedgerow case

study, potentially with Xerces Society Biologist on plant selection and the farmer who implemented the project
