2024 VERIFICATION PROJECT UPDATE

The Verification Project commenced in August this year, and the Madera County GSA has already gathered high-quality meter data. At the end of the year, this data will be compared with measurements from other satellite-based methods, including Land IQ and Irriwatch-Hydrostat. All participants will have the opportunity to review

the results at that time. The Water Resources Specialists are actively coordinating with participating growers to conduct on-site field work and gather verification data.

After pre-applications are reviewed, invitations will be sent to those who meet program eligibility requirements to begin the project proposal development process. Thank you for attending the Madera County Multibenefit Land Repurposing Program (MLRP) workshop for pre-applicants that was held virtually on November 8. We appreciate your participation and interest in the program!

As we shared in the workshop, the next step for participating in the Madera County MLRP is to submit a <u>Pre-Application Form</u> by the **November 22 deadline**. The form is a required first step to ensure eligibility before you begin developing a full application. Pre-Applications will be reviewed following the November 22 deadline. Each preapplicant will receive a response from the Madera MLRP team by December 4 with notification of eligibility. Pre-applicants that meet the eligibility requirements will be invited to participate in the full application development process, including more information about accessing technical assistance services. The Full-Application template document will also be provided at that time.
